

# CONNECTICUT CHILD TAX REBATE

\$250 per child (up to \$750)



\*Applications due by **July 31, 2022**

The 2022 Child Tax Rebate is intended to help Connecticut families with children by issuing families a rebate of up to \$750 (\$250 per child, up to three children). This payment is a rebate, meaning you will not have to repay or reconcile the payment received on your 2022 tax return.

Heads up - there is a short window of time to apply so be sure to submit your application by July 31st!

We're here to provide you with answers to questions you may have when determining your eligibility to participate in the program and how you can apply.

## DO I QUALIFY?

To be eligible for the rebate you must meet **ALL** of the following requirements:

- You must be a resident of Connecticut;
- You must have claimed at least one child as a dependent on your 2021 Federal Income Tax Return who was 18 years of age or younger; **and**
- You must meet the income limits described below.

**IMPORTANT:** If you have not filed your 2021 tax return, you will need to file by July 31st in order to apply. The State of CT will not accept applications based on information from your 2020 tax return. If you have not filed and believe you may be eligible, please contact and provide your 2021 tax documents to your FKCo tax preparer. Tax documents received after July 1st cannot guarantee filing by the program cut off date.

## WHAT ARE THE INCOME LIMITATIONS?

In order to qualify for the rebate, your 2021 Adjusted Gross Income ("AGI") must be less than or equal to the below limits:

2021 Filing Status	2021 Adjusted Gross Income	*Phase-out Threshold
Single/MFS	Up to \$100,000	\$100,000 - \$110,000
Head of Household	Up to \$160,000	\$160,000 - \$170,000
Married Filing Joint/QW	Up to \$200,000	\$200,000 - \$210,000

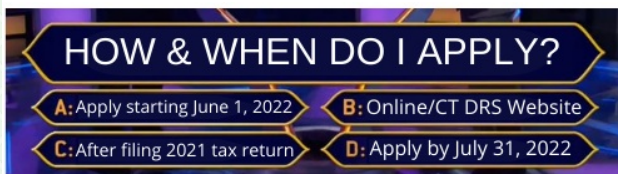
\*You may be eligible for a portion of the rebate if your income exceeds the AGI limits but falls within the "phase-out" threshold. [CLICK HERE](#) to see if you qualify for a reduced rebate payment.
